This appeal comes to you on your 65<sup>th</sup> birthday, on behalf of the Bruce Peninsula Environment Group (BPEG), a non-profit community organization, founded in 1989, based in Lion's Head, Bruce County, Ontario. Happy birthday Mr. Minister!

The Federal Commissioner of the Environment and Sustainable Development released her Fall 2016 Report last week (October 4th). She issued a devastating report card on the performance of the Canadian Nuclear Safety Commission (CNSC), the Federal Nuclear Regulator, part of your ministry's portfolio.


We have constantly been assured by CNSC's Chair and CEO and especially by its Executive Vice-President and Chief Regulatory Officer of the Regulatory Operations Branch that the CNSC takes every step to ensure public health and safety, without compromise, at all Canadian nuclear plants it regulates. As stated in the 2016 CNSC Annual Report, "We enforce our very strict regulatory requirements and vigilantly monitor licensees to verify they are following the rules."

The Federal Commissioner of the Environment and Sustainable Development disagrees strongly and has very serious problems with the execution of CNSC's duties. We expected, by their admission of such failures of their public duties, that those two highest CNSC officers would have tendered their resignations, having agreed with the reported failures in their oversight.

As this does not seem to be forthcoming we call on you, Minister Carr, as the [cabinet member](#) responsible for the conduct of the CNSC, to relieve these two persons of their duties. This action is necessary to restore Canadians' trust and respect for the upholding of safety and security standards entrusted to you under your portfolio.

We request a response [within 30 days](#) to this Appeal for Action; this is an open letter.
